The latest General Membership Meeting took place on February 8th. Some of the news updates are listed below:

- IBEW Founders' Scholarship applications are due by May 1st
- Reading of the Executive Board meeting minutes from January 8th and January 22nd

• Trial Board report from January 16th. The Executive Board acts as the Trial Board of Local 3.

• 124 years ago, in February 1900, Local Assembly 5468 of the Knights of Labor affiliated with the International Brotherhood of Electrical Workers (IBEW) as Local Union 3. The 125th anniversary celebration will be held next year.

• The 37th Annual Spring Art Festival will be hosted by the JIB on May 6th-11th.

• General Membership meeting was called into recess and the Electrical Workers Death Benefit Society (EWDBS) Board of Directors 85th annual meeting was called into session by vote of the members present. 10 incumbent directors were re-elected, as no competing nominations were declared, and Recording Secretary Michael Loreto submitted 1 vote per incumbent director. • New phase of the Furlough Plan started on January 2nd.

• IBEW Officers meeting on February 5th-6th in Washington, D.C. International President Ken Cooper announced future work opportunities (chip plants, solar farms, transmission lines, etc.). Organizing goal of 1 million IBEW members in the U.S. and Canada. Local 3 members approved the hire of rank and file organizers.

• Received two letters of appreciation from signatory contractors for Local 3 members' contributions to the Target Fund to help successful bids (NEAD Electric and E-J Electric).
